1. Media facilities are provided for the sole use of working media only.
2. Accreditation passes will be available for collection on Friday 30 March 2012.
3. An accreditation pass **WILL NOT** permit access to VIP or Semi VIP areas.
4. Submission of this application form will be assumed to be an acceptance of the terms and conditions, which are set out below.

PRIORITY FOR ACCREDITATION

1. Recognised National Photographic Agencies.
2. Local Newspapers.
3. National Newspapers.
4. Recognised Aerial Publications.
5. Aerial Magazines.
6. Photographers Representing Defence Institutions.
7. Freelancer Aerial Photographers.
8. Website photographer.

Freelance photographers will be required to provide:

- a. Proof of commission to support the application.
- b. Three pieces of photographic work published in the last six months.

Terms and Conditions of Accreditation

1. In consideration of Accreditation being granted to a person ("Pass Holder") for the Overberg Air Show, the Pass Holder and the organisation they represent ("Principal") agree at all times during the Event (whether or not the Pass Holder is in an accredited area) to comply with these terms and conditions and any other terms and conditions imposed by Air Force Base Overberg(TFDC).
2. Accreditation may not be shared with, or transferred or assigned to, any person or entity.
3. Accreditation passes are, and remain at all times, the property of Air Force Base Overberg (TFDC).
4. The Pass Holder and Principal shall at all times comply with all:

a. terms, conditions, rules and regulations pertaining to the Event as prescribed by Air Force Base Overberg (TFDC) from time to time (including, without limitation, these terms and conditions);

- b. directions from any official or representative of Air Force Base Overberg (TFDC);
- c. event policies and decisions issued by SA Air Force Base Overberg (TFDC) in relation to the Event;
- d. the rules and regulations relating to any Event Venue ("Venue"); and
- e. the directions from Venue representatives and/or officials.

5. Any breach of these terms and conditions shall entitle Air Force Base Overberg (TFDC) in its sole opinion to suspend, withdraw, revoke or cancel Accreditation in which case all rights conferred or evidenced by it shall be null and void. Where reasonably practical Air Force Base Overberg (TFDC) will notify the Pass Holder and Principal of any considered breach, and will give them the opportunity to comment or remedy the breach, before any action in relation to the Accreditation. This does not however prevent Air Force Base Overberg (TFDC) from acting summarily if, in its sole opinion, the circumstances warrant it. The suspension, withdrawal, revocation or cancellation of Accreditation by Air Force Base Overberg (TFDC) shall not prejudice any other rights or remedies SA Rugby may have against the Pass Holder or a Principal.

6. The Pass Holder and the Principal shall indemnify and hold harmless Air Force Base Overberg (TFDC), its employees, officers and agents against any loss or damage, resulting from a breach of these terms and conditions by a Pass Holder and/or Principal or resulting from the suspension, withdrawal, revocation or cancellation of Accreditation. Air Force Base Overberg (TFDC) shall indemnify and hold harmless the Pass Holder and Principle, its employees, officers and agents against any loss or damage, resulting from a breach of these terms and conditions by Air Force Base Overberg (TFDC).

7. The Pass Holder and the Principal understand and accept as essential terms and conditions of the issue of Accreditation that:

- b. **Out of Bounds:** Accredited photographers must not take photographs in restricted areas as prescribed by Air Force Base Overberg (TFDC).

8. Without limiting any of Air Force Base Overberg's (TFDC) other rights, any breach of clause 7 will result in the Pass Holder's Accreditation being immediately cancelled, cofescation of media and may result in the non-Accreditation of the Pass Holder and/or Principal in the future.

9. Pass Holders may not bring into any Venue any prohibited items, including but not limited to, weapons, flares, sharp objects, bottles, cans, prohibited containers, or other items prohibited by or on behalf of Air Force Base Overberg (TFDC). Pass Holders may be searched for any prohibited items and/or non-approved equipment into a Venue.

10. The Pass Holder and Principal shall not cause or permit the use of any material recorded by the Pass Holder to be used in any way which:

- a. is likely to challenge, damage, prejudice and/or undermine the intellectual property rights of Air Force Base Overberg (TFDC), the Event and/or any participant in the Event; and/or
- b. assist or lead to any ambush marketing of the Event.

11. Accreditation documentation (as provided by Air Force Base Overberg (TFDC)) must be worn or displayed by the Pass Holder at all times as a condition of entry into any accredited area and/or other locations prescribed by Air Force Base Overberg (TFDC).

12. The Pass Holder and/or Principal shall not tamper in any way with or obscure, or allow any other unaccredited person to use, any Accreditation documentation.

13. Pass Holders and Principals agree to conduct themselves in a way that will not bring the Event and/or Air Force Base Overberg (TFDC) into disrepute.

14. Applicants may be asked to provide examples of previous work prior to Accreditation being granted or at anytime following Accreditation. If such work is not provided within the time designated by Air Force Base Overberg (TFDC), then either the application for Accreditation will be declined or any Accreditation granted may be suspended, withdrawn, revoked or cancelled (as the case may be).

15. For the avoidance of doubt, the intellectual property rights of any accredited individual, organisation or publication are only affected to the extent expressly set out in these terms and conditions. Air Force Base Overberg (TFDC) agrees that all copyright in material created by the Accredited Party, including newspaper or news agency representative at the Events will be owned by the Accredited Party and/or publisher/news agency. All such material may be used, subject to these terms and conditions, for any Editorial Purposes.

16. For further avoidance of doubt, nothing in these Terms and Conditions of Accreditation is intended to be, or shall be interpreted as, restricting or preventing the exercise of legitimate journalistic practices including reporting, comment and criticism.
